PARENT/STUDENT CONTRACT

- PAYMENTS:** All payments are due on the posted dates, checks payable to YOCJ:
Tuesday October 17 – Payment #1 due: \$1000 per person
Tuesday December 5 – Payment #2 due: \$1000 per person
Tuesday February 6 – Payment #3 due: \$1000 per person Regular & Extended. \$250 Land-only
Tuesday April 30 – Final Payments and all TBD fees are due
Please put your YOCJ child's name on the memo line. Any returned check bank fees will be charged to the YOCJ family.
- TRIP INSURANCE** is highly recommended. You are responsible for obtaining your own trip insurance. Review your options on sites such as www.insuremytrip.com
- REFUNDS** will only be available as follows:
 - *Full refunds (less a \$100 non-refundable fee) are available up until March 22
 - *March 23-May 7: 10% of trip cost cancellation fee (less a \$100 non-refundable fee)
 - *May 8-May 23: 20% of trip cost cancellation fee (less a \$100 non-refundable fee)
 - *May 24-June 7: 35% of trip cost cancellation fee (less a \$100 non-refundable fee)
 - *June 8-June 18: 60% of trip cost cancellation fee (less a \$100 non-refundable fee)
 - *June 19 and on: 100% of trip cost cancellation fee
- CANCELLATION WAIVER:** Due to current world events, the YOCJ Board of Directors reserves the right to cancel the trip if it determines that cancellation is in the best interests of the safety of students and chaperones. Cancellation shall be at the sole discretion of the YOCJ Board of Directors. Your electronic signature confirms your agreement that in the event of such cancellation you will hold the YOCJ Board of Directors, its past, present and future members, its employees and all conductors harmless for any costs or expenses related or arising from a cancellation of the trip, including but not limited to any prepayments for airfare, lodging or other expenses associated with the student's participation on the trip that are not refunded and any claims made by any other party related to any financial obligation associated with the trip.
- DISMISSAL:** Any student found under the influence of or in possession of an alcoholic beverage or illicit substance will be sent home at their parents' expense and will be subject to dismissal from YOCJ without any refund of trip cost or YOCJ tuition.
- NO SMOKING** is permitted on the trip.
- ACCEPTANCE:** Even if your child is or will be 18 years old at the time of the trip, an electronic registration by a parent/guardian on the YOCJ Registration Google Form is still required. Registering your child and any family members on the YOCJ Registration Google Form will be considered your acceptance of the terms of this YOCJ Student/Parent Contract.
